AFFIRMATION OF CHARLES WEINSTOCK

CHARLES WEINSTOCK, an attorney admitted to practice before the courts of the State of New York, affirms under penalty of perjury:

- 1. I am an attorney for Petitioners-Plaintiffs ("Petitioners") and am fully familiar with the facts of the case. I submit this affirmation in support of their challenge to (1) the plan by Respondent-Defendant ("Respondent") New York State Urban Development Corporation, doing business as New York State Empire State Development ("ESD"), to override the City's zoning laws and grant 18 million square feet of development rights to the owners of eight parcels surrounding Penn Station; and (2) the resolution issued by Respondent Public Authorities Control Board ("PACB") authorizing ESD to enter into a revenue-sharing agreement with New York City in connection with the financing of the project.
- 2. In their Request for Judicial Intervention, Petitioners marked this proceeding as related to an Article 78 Freedom of Information Law ("FOIL") case, currently pending in

this Court, in which I am the petitioner: *Weinstock v. N.Y.S. Urban Development Corp.*, Index No. 157448/2022 (Sup. Ct. N.Y. Co. 2022) (Billing, J.) ("FOIL Suit"). The decision whether two cases are related is within the discretion of the Court. *Morfesis v. Wilk*, 138 A.D.2d 244, 246 (1st Dep't 1988).

- 3. In this instance, the two cases are related because they challenge the same governmental action—Respondent ESD's proposed zoning override. In the FOIL Suit, I challenged the agency's continuing failure to produce public documents relating to this plan, material that Petitioners believe is directly relevant to the claims they make here. *See*Verified Petition, Index No. 157448/2022, Dkt. 1 ¶ 1. I have attached as Exhibits F-1 to F-6 the documents that ESD has produced to date, which Petitioners cite at length in their brief. *See, e.g.*, Petitioners' Memorandum of Law at 25-29. Petitioners believe that the documents ESD continues to withhold would also be relevant to central issues in the present case—in particular, "the scale of the buildings that ESD would allow Vornado and the other property owners to build; the environmental effects of the project; and, above all, the project's questionable funding." Verified Petition, Index No. 157448/2022, Dkt. 1 ¶ 9. Given the overlapping subject matter, it is in the interest of judicial economy and efficiency for this Court to hear them as related cases.
- 4. Petitioners also request that the Court set an early return date because PACB's resolution authorizes ESD to continue taking actions to implement the plan—including the negotiation of development agreements with the property owners. Petitioners are concerned that, as the plan progresses, the owners will be more emboldened to demolish historic buildings on their properties, or take other irreversible actions that could impact Petitioners.

5. Petitioners also request that the Court permit them to submit a 60-page Memorandum of Law, exceeding the 30-page limit set out in Rule 14(b) of this Court's Rules of the Justices. Petitioners have good cause to file excess pages. The project plan that they challenge is dense and cannot be described quickly. Moreover, the supporting documents that ESD prepared in connection with the reviews under the State Environmental Quality Review Act ("SEQRA") and the Urban Development Corporation Act ("UDCA") are voluminous. The SEQRA Final Environmental Impact Statement alone is nearly 2,000 complex, often technical pages; the UDCA General Project Plan and its attachments run to just under 700 pages. They require detailed response on both the facts and the law.

- 6. In addition to this Memorandum of Law, I have attached (1) the affidavit of Richard Ravitch, the former Lieutenant Governor and former chair of both the Urban Development Corporation and the Metropolitan Transportation Authority, sworn to October 19, 2022; and (2) the affidavit of George M. Janes, principal of George M. Janes & Associates, an urban planning and zoning consultancy, sworn to October 24, 2022.
